

8TH RedCUIDAR+ MEETING

Community and Inclusive Care: Needs, Practices and Lessons Learned

Thursday, May 25, 2023

CONCEPT NOTE

The Long-Term Care Policy Network in Latin America and the Caribbean (RedCUIDAR+) was created in 2020 to support Latin America and Caribbean countries' efforts to expand long-term care services for care-dependent older people and increase their institutional and technical capacity in this area. The initiative is supported by the Inter-American Development Bank (IDB), the European Union's EUROsociAL+ Program, and the French Development Agency (AFD).

The Government of the Republic of Colombia will host the eighth meeting of RedCUIDAR+ with the theme **Community and Inclusive Care: Needs, Practices and Lessons Learned**.

The eighth meeting of RedCUIDAR+ is meant to be a space for exchanging experiences and best practices on policies, programs, projects, and actions that have promoted community-based and inclusive care for older persons, including the dynamics related to different ethnic groups. With these inputs, the aim is to identify support mechanisms that governments can design for communities. This note briefly describes the three experiences that will be presented at the event.

National Care System and the "Manzanas del cuidado" in Bogotá, Colombia

The process of building the National Care System in Colombia aims to consolidate an institutional architecture to realize both the promotion of a new social organization of care and the recognition of care as a right. The ultimate goal is to create, expand, and regulate care services that cater to the diverse needs of the population in an inclusive and ethnically diverse manner.

This presentation will discuss the challenges and advances in the configuration of a National Care System that seeks to recognize and make visible community-based care through processes and initiatives developed by organizations in the territories in a participatory manner and that provide the necessary care to the target population. In Bogotá, a pioneer in implementing care systems in the region, the "Manzanas del cuidado" operate as areas that articulate the needs for care with caregiving programs and services in a framework of co-responsibility between the local government, the central government, the private sector, communities, and households.

Community Care System "STGO te cuida": the Care Brigade in Santiago, Chile

The Care Brigade is an initiative created in the context of the COVID-19 pandemic, to complement the volunteer program of the municipality of Santiago. The idea from the beginning was to cover

two needs, on the one hand, to assist the older persons without support networks, and, on the other hand, to provide employment options to women without a source of income.

The program was originally called "*Mujeres en terreno*" (Women in the territory), but it was later renamed to "*Brigada de Cuidados*" (Care Brigade) to emphasize the importance of shared responsibility in the field of care. Among its tasks are: providing assistance and accompaniment to older persons, temporarily supporting the caregiver to have time for self-care or other activities, requesting relief hours and providing skills in caregiving, promoting labor market insertion by providing job training and certification.

Program for Supporting Older Persons in São Paulo

The PAI (in Portuguese "Programa Acompanhante de Idosos - PAI") is a pioneering initiative implemented in the city of São Paulo to assist vulnerable older people. The program is one of the most significant components of the city's Health Care Network for Older People. The PAI aims to provide assistance with activities of daily living (advanced, instrumental, and basic) and to establish a support network that involves the individual, family and community in accessing local resources.

The beneficiaries of the initiative receive a multidimensional geriatric assessment at the city's basic health units, and if they meet the program's inclusion criteria, they are referred to a team responsible for developing a care plan. This plan includes interventions from a multidisciplinary team comprising a social worker (or coordinator), a healthcare team (physician, nurse, and nursing technician), and a caregiver. In this way, the PAI provides an integrated and personalized care. Currently, the program comprises 50 teams that assist about 6,000 older persons.
